In addition, after the third (3 rd) unexcused tardy to school, or third (3 rd) unexcused early dismissal from school, or tenth (10 th) unexcused absence from school, I understand that my driving privilege shall be suspended for a minimum of 30 school days. After the sixth (6 th) unexcused tardy to school, or sixth (6 th) unexcused early dismissal from school, or thirteenth (13 th) unexcused absence from school, I understand that my driving privilege shall be terminated for the remainder of the school year.	
If I receive one (1) out-of-school suspension or a third (3 rd) in-school-suspension, I understand that my driving privilege shall be suspended for a minimum of 30 school days. If I receive a second (2 nd) out-of-school suspension or a fourth (4 th) in-school-suspension, I understand that my driving privilege shall be terminated for the remainder of the school year. If my privilege is taken, I am also aware that Wal-Mart will no longer tolerate student parking on their property and will tow unauthorized vehicles.
