AP Research students investigate distinct topics

Students taking AP Research develop hypotheses on topics that spark an interest and are relevant to them. Their end goal is to defend their topic and come up with beneficial solutions for their hypothesis. Each individual student conducts their own research project which entails a lengthy paper and an oral presentation. This provides the graders with insight and solutions about their topic.

Prior to taking AP Research, students must take the preceding class, AP Seminar. AP Seminar teaches students how to analyze work that has already been done in fields like humanities and STEM.

The student's research gets approved by the IRB in a rolling manner from late November to mid-February. The Institutional Review Board is a group of determine if the projects are feasible.

Six AP Research students have had their topics approved by the IRB.

Senior Olivia Choi is researching the olfactory sensory system and how nostalgia affects one's heart rate. Choi is focusing on the heart rate variability of Delaware Valley students by exposing them to a scent that makes them experience emotional memories.

Senior Cassandra Joyce is researching the difference between in-season vs. offseason grade point averages for student-athletes. Joyce plans to analyze grade point averages of graduating seniors from the classes of 2022 and 2023, and will then look at if the difference between in-season and offseason GPA is statistically significant for these student-athletes.

Senior Mackenzie Donald will focus on the effect of psycho-sizing on customer satisfaction. Donald will

Epstein list strikes controversy in eyes of misconstrued media

The list of known associates and victims of Jeffrey Epstein, a deceased sex-offender, became public following a court ruling on Jan. 3 and 4. Epstein was a financier who was charged with one count of the sex trafficking of minors in July 2019, and then died just one month later in his jail cell. The term "The List" has been coined by many popular news sources, and when it was unsealed, caused quite a stir throughout the media and public due to the overdramatization and misconceptions surrounding it. Some of the names that were released were those of people in power and in pop culture, like former president Donald Trump and German model Heidi Klum.

People have different interpretations of what the Epstein list means. Common misconceptions were that the revealed names were those of "clients" or "co-conspirators" due to the list's popularity on social media. The media can sometimes sensationalize or misinterpret information, so it's crucial to verify facts and rely on credible sources.

Some also believe that everyone on the list is involved in illegal activities. However, it's important to remember that the list itself is not definitive proof of guilt or innocence. It's simply a record of connections. The actual meaning of the list can only be determined through thorough investigation and legal proceedings. In light of her release from prison, Gypsy Rose Blanchard has recently received the spotlight and overwhelming support across all social media platforms.

Gypsy was released from a Missouri prison on Dec. 28 after completing 85% of her 10-year sentence. She was arrested on June 15, 2015, after pleading guilty for her role in her mother's murder.

Gypsy's mother, Dee Dee Blanchard, had fabricated stories, making her daughter and those around them believe that Gypsy suffered from leukemia, muscular dystrophy and numerous other medical conditions. Dee Dee chronicled their lives on social media, gaining a large following.

When Gypsy began to realize she was not actually sick, she plotted her mother's murder with her boyfriend Nick Godejohn. Godejohn committed the murder, stabbing Dee Dee to death with the knife that Gypsy gave him.

While Gypsy only received a sentence of 10 years, Godejohn was sentenced to life in prison and an extra 25 years for armed criminal action.

As soon as Gypsy was released from prison, she began posting on TikTok and Instagram. Her posts started going viral and began to gain millions of followers. Many of her followers began making edits and hashtags for her to spread support.

When considering the facts and details of Gypsy's case, it is only reasonable to question why we as consumers are glorifying this situation. How are we idolizing someone who planned her own mother's murder?





In 2004, the Danbury Trashers were born: a United Hockey League team bought by Genovese crime family member and inspiration for Tony Soprano, Jimmy Galante, for his 17-year-old son A.J..

A.J. Galante found a love for hockey after watching "The Mighty Ducks" as a child. He played until suffering a career-ending injury to his leg in high school. In addition to hockey, he was a huge WWE fan. Naturally, when he was gifted a hockey team, he combined the two interests into one.

The first player signed by the Trashers was Brett Gretzky, the younger brother of NHL legend Wayne Gretzky. Former NHL players Rumun Ndur and Mike Rupp were early acquisitions, as well as ex-convict Brad Wingfield, David "One Eye Willy" Beauregard and rowdy brothers Mike and Drew Omicioli. They were tough and gritty guys who had one goal: beat up everyone they stepped on the ice with, giving A.J. Galante his WWE-hockey dreams.

Very quickly, the self-proclaimed "bad boys of hockey" kept gaining more and more attention. Fans filled the arena to watch the fights, antics and a skilled team. In their first season, the Trashers finished 44-29 and made it to the second round of playoffs. In their second season, they ended with a 48-17 record and lost in the championship game. However, the downfall of the Trashers began just after the end of their second season. Jimmy Galante was indicted on 72 charges relating to his garbage disposal company and the Trashers, including racketeering, defrauding the UHL and wire fraud.

Although short lived, the Trashers left a lasting impact on Danbury and the hockey community as a whole. The bad boys were suddenly the heroes, and fans still can't get enough. Netflix released a documentary about the team in 2021, and Trashers' merchandise is still available to buy online.

Houston Astros accused of cheating

The Houston Astros cheating scandal in the 2017-18 season was a major controversy in baseball. The controversy involved the Astros using technology to steal signs from their opposing teams during their 2017 World Series winning season. According to MLB investigators, the Astros used their replay review camera feed in centerfield to steal opponents' signs.

Also according to the investigation, one of the Astros players would act as a "runner" and would allegedly relay signs to teammates and eventually the batter on the next pitch the pitcher needed

The scandal shook the baseball world and raised many questions about the integrity of the game, and many fans and players were disappointed and saw the Astros' actions as undermining the fairness of competition.

The Astros were also accused of cheating in the American League Championship in 2019 when Jose Altuve hit the game winning homerun against the New York Yankees to send the Astros to the World Series.

As his teammates were about to mob him at home plate, he allegedly asked them not to rip off his jersey because he was supposedly wearing a buzzer underneath, which indicated to him what pitch was coming next. Although no evidence was found, this rumor still angered many fans and teams.

After the conclusion of the MLB's investigation, many penalties were issued to both players and coaches. The Astros fired manager A.J. Hinch and general manager Jeff Lunhow in 2020, after Major League Baseball fined the club \$5 million and docked them several top draft picks.

After this controversy, the Astros' reputation may be tarnished some and will forever have a lasting impact on the baseball industry.

Curse of the Bambino

Between 1918 and 2004, the Boston Red Sox failed to win a single World Series- with the only reasonable explanation being an ill-fated curse. Before Babe Ruth gained most of his fame with the New York Yankees, he was winning the World Series with the Red Sox. During his six-year tenure with the team, he won it all three times. After the 1919 season, Red Sox owner Harry Frazee did the unimaginable, selling Ruth to the rival Yankees for \$120,000 and a \$300,000 loan. This led to the 86 years of misery for the Red Sox with them not winning a single World Series.

They were told that Sianis was allowed into the stadium, but his goat was banned. When Cubs owner P.K. Wrigley explained that the goat couldn't go inside because he "stinks," Sianis cursed them to never win another World Series.

Curse of the Terrible Towel

The Pittsburgh Steelers' Terrible Towel is one of the NFL's most recognizable symbols. While it's mostly used by fans to show their team spirit, the Terrible Towel has a history of ruining seasons of disrespectful opposition. The first instance of this curse was during the 1994-95 season when a player on the San Diego Chargers disrespected the Towel after beating the Steelers in the AFC Championship game. They went on to lose the Super Bowl and have not been back since. This isn't the only case of the Terrible Towel Curse. In this latest NFL season, during the week eight Steelers and Jaguars game, several players used the Towel to taunt after defeating the Steelers. The Jaguars proceeded to end their season with a 3-7 record, and lost out on a playoff spot to the Steelers.

Bobby Layne's Curse on the Lions

Before the Detroit Lions became the laughing stock of the NFL, they were a powerhouse team, specifically in the 1950s. Groundwater levels depleting worldwide

Around the world, aquifers, which hold groundwater, have had dramatically declining water levels. This could affect millions of people.

In parts of the world where water is scarce, people rely on these aquifers as their only access to fresh water or for irrigation. If these water sources deplete, it could potentially lead to land subsidence, which is a gradual setting of the Earth's surface.

Between 2000 to 2022, a study conducted showed that 71% of 1,693 aquifer systems have been declining and 36% have been declining over 0.1 meter a year.

"This study was driven by curiosity," assistant professor in University of California's Santa Barbara's Environmental Program Debra Perrone said. "We wanted to better understand the state of global groundwater by wrangling millions of groundwater level measurements."

countries showed that groundwater levels have highest decline rate with a median decline of around 2.95 meters per year. Several aquifers in Iran have also shown rapid declines of groundwater reduction, but there hasn't been as much data from Africa.

Yet, there have been studies that show some examples of groundwater recovery after interventions.

Comparing data from groundwater levels from 1980 to 2000 in 542 aguifers showed that 30% of the groundwater levels have fallen faster since 2000 than they did prior. In 20% of aquifers, groundwater levels have declined at a much slower rate, with 16% reversing entirely and are now rising.

A correlation researchers have identified is it might involve the change in the amount of precipitation over a particular region with 80% of the aquifers with an accelerating decline also experiencing decreased precipitation.

Doomsday clock set at 90 seconds to midnight for second consecutive year

The Doomsday Clock, which represents humanity's closeness to global catastrophe, has remained at its latest ever time for the second year in a row.

The clock, founded by Albert Einstein in conjunction with the University of Chicago, is managed by the university's Bulletin of the Atomic Scientists and updated once each year. This is a carefully contemplated decision based upon global issues such as climate change. The Bulletin of the Atomic Scientists conveyed an arguably grim message regarding the state of global affairs in their statement released Jan. 24.

"There is no clear pathway for forging a just peace that discourages future aggression under the shadow of nuclear weapons," the 2024 statement

by the Bulletin of Atomic Scientists said.

Due to continued tensions, particularly the war between Russia and Ukraine, the scientists encourage taking measures to minimize the chance for escalation.

"In this time of unprecedented global danger, concerted action is required, and every second counts," the statement said.



Fatal earthquake rattles western China

At least three people were killed and five others were injured in a 7.1 magnitude earthquake that struck China right near the Kyrgyzstan-Xinjiang border region early in the morning on Jan. 23. Over 12,000 people who weren't injured or killed were sent to take shelter in freezing weather with only tents and bonfires to rely on.

The quake was felt as far away as Uzbekistan. The countries Kazakhstan and Tajikistan were also affected by this earthquake. Over 120 buildings were damaged, 47 homes had collapsed, and 78 more were damaged. Most rescue missions took place in Wushi county, which is also known as Uchturpan County, where temperatures are well below freezing. Wushi County had a population of over 233,000 in 2022.

China Meteorological The Administration forecast was reaching temperatures as low as -18 degrees

celsius that week. The quake caused the power lines to break but electricity was quickly restored. The area's largest earthquake in the past century was also a 7.1 magnitude earthquake that occurred in 1978. Multiple aftershocks were recorded on Jan. 23; the strongest measured was a 5.3 magnitude.

Videos found from Xinjiang residents can show chandeliers swinging and falling to the floor, crowds evacuating from apartments and crowds taking shelter outside in the streets as overnight temperatures were at -10 degrees celsius.

Near the country of Kazakhstan, at least 44 people were injured from the earthquake. Earthquakes are not uncommon in this part of China. A 6.2 magnitude earthquake struck the provinces of Gansu Qinghai in northwest China killing over 150 people. This earthquake that took place in December was China's most fatal earthquake in nine years.

Epstein Island under critical firestorm

On Dec. 18, court documents became unsealed, revealing dozens of people with a wide variety of connections to known sex offender Jeffrey Epstein.

Many of the names on the documents include his staff members and business associates, much of whom have given depositions about the offender who allegedly exploited underage girls for sex in his homes, but namely on his private island Little St. James.

Owned by Epstein, Little St. James is a 72-acre island including several villas, just about two miles off of the coast of St. Thomas, which is part of the U.S. Virgin Islands.

Epstein had stakes in businesses in the Virgin Islands, giving him the opportunity to use the benefits of Hyperion Air, like the helicopters he used to transport the girls from St. Thomas to Little St. James.

In 2019, Epstein was arrested on federal sex trafficking charges. He pleaded not guilty, but later committed suicide in a New York prison before facing trial.

U.S. Virgin Islands Attorney General Denise George sued Epstein's estate and won a \$105 million settlement on behalf of the Virgin Islands.

"What I do know is that because of Epstein's wealth and power, he was able to conceal this," George said.

Many of Epstein's scandals remain unknown. It was also revealed that previous to being arrested in 2019, Epstein was also in legal trouble in 2008.

He pleaded guilty to two state charges of soliciting prostitution from a minor in Florida, but was cut a deal and only served 13 months in jail, spending most of that time on work release and paid settlements to the victims.

While the

documents did not contain an actual list of Epstein's associates, it did contain names of people who have been associated in some ways. His flight logs have also been made public, showing the plane often being used to fly to the U.S. Virgin Islands.

Just being named in these documents proves no wrongdoing, but names associated with Epstein are under criticism to the public eye.

Mississippi woman hides son's body behind false wall

Mississippi woman Jerri Lynn Isreal, 66, was charged with first-degree murder on Jan. 20. After receiving phone calls about a missing person on Dec. 22, authorities began an investigation that lasted several weeks.

As the missing person reports came in, Isreal was brought in for questioning numerous times.

"Throughout the course of the investigation, Isreal became increasingly uncooperative and

changed her statements multiple times," the police 170department said.

Thirty years ago, Isreal 160was charged with murder in Florida, where she attempted to dump the 140 body in multiple locations throughout the state. This record allowed detectives



to obtain a warrant to search Israel's home.

Police and crime scene technicians searched the home on Jan. 18 where they found a wooden box in a fake wall. Inside was missing person John Allen Gaither's, 42, deceased body.

When authorities walked into her house for the search, Israel consumed a handful of pills. After, she was transported to a local hospital for treatment. Two days later, she was charged with murdering her son.

Additionally, police found notes to Isreal's family members posing as

> her son in an attempt to cover up the murder. Authorities also found more homemade wooden boxes in her home and garage.

She is now being held at the Harrison County Adult Detention Center in Mississippi.

U.S. inmate faces first nitrogen execution

to take a step backwards."

U.S. inmate Kenneth Eugene Smith was the first person to be sentenced to death by nitrogen gas on Jan. 25. Smith, 58, was convicted in 1989 for killing Elizabeth Sennett, 45, and has been on death row since 1996.

The protocol in Alabama calls for the condemned inmate to be strapped

to a gurney and fitted with a mask connected to a breathing tube that administers 100% pure nitrogen to

the inmate until they die.

There were multiple worries that this method of death was "recently released and untested" and could not be trusted. Smith's spiritual adviser, Reverend Jeff Hood, was in the execution room and believed there would be danger if the

nitrogen leaked.

'Tonight Alabama causes humanity to take a step backwards," Smith said as his final statement.

Smith began to shake and writhe violently, in thrashing spasms and seizure-like movements, around 7:58 p.m. He took a series of deep gasping breaths, his chest rising noticeably. His breathing was no longer visible at about 8:08 p.m.

"As of

last night, nitrogen as is no

longer an untested method. It is a proven one. It's the method that Kenny Smith ultimately chose," Attorney General Steve Marshall said.





Overall, the movie was an interesting and well-made story to explain the origin of Wonka's life story.



MIT researchers design breakthrough sensor

Researchers at the Massachusetts Institute of Technology (MIT) have recently designed heat sensors that can operate without the need for batteries or recharging. The sensor can obtain its

energy in open air from the magnetic field generated around a wire.

The absence of a battery, while minimizing complexity, also diminishes the risk of a fire. In the battery's place, the researchers used capacitors, which can be tuned to fit a required space, fulfill

operating conditions and comply with safety requirements.

The device can be clipped onto a wire to receive power and to monitor a machine's temperature and power consumption. The sensor is also able to cold start, or turn its electronic components on without the need for an initial voltage via circuits.

The sensor can be efficiently installed to monitor various machines, including ship engines.

"This is ambient power - energy that I don't have to make a specific, soldered connection to get. And that makes this sensor very easy to install," Steve Leeb, author of a paper about the senior

the sensor and professor of electrical engineering and computer science at MIT, said.

The researchers believe that the breakthrough can facilitate the development of sensors for various

applications, like

"We have provided an example of a battery-less sensor that does something useful and shown that it is a practically realizable solution," Daniel Monagle, the paper's lead author and electrical engineering and computer science graduate student at MIT, said.

U.S. spacecraft fails moon landing mission

Following decades since the last time the U.S. landed a spacecraft on the moon, Astrobotic and NASA's Peregrine lunar lander would have been the first U.S. mission to land on

the moon since the Apollo 17 mission in 1972. Due to a fuel leak however, the mission ended up as a failure.

Astrobotic Technology, the Pittsburgh-based company which helped develop Peregrine under contract with

NASA, has the main goal of creating commercially developed and relatively cheap spacecraft that would be capable of carrying out robotic missions to the moon.

On Jan. 8, the Peregrine lander was launched successfully into orbit

By BRIAN RODRIGUEZ-HERNANDEZ atop a Vulcan Centaur Rocket, developed by United Launch Alliance, a collaboration between Lockheed Martin and Boeing. However, the fuel leak subsequently left the lander short of enough gas to land onto the moon.

> The lander then remained in orbit for 10 days, where its onboard scientific instruments were used and tested.

> > On Jan. 18 around 4 p.m. ET, the launcher reentered Earth over the southern Pacific Ocean.

Astrobotic already has plans later this year to land a bigger spacecraft called Griffin near the south pole of the moon.

"We're in a high-risk space venture, and this is just the nature of space businesses," Astrobotic's Thornton said.


Promising drug combats glioblastoma

Scientists have developed a customized drug that kills glioblastoma cells without damaging healthy cells. The drug, a modified version of temozolomide, also known as TMZ, is not able to actively distinguish between healthy and cancerous cells; rather, it attacks every cell, but only cancer cells die since only healthy cells possess the necessary protein that allows it to heal. This protein is called MGMT, and it often plays a vital role in the process of DNA repair. Glioblastoma, the most common type of brain cancer in adults, typically possesses low amounts of this protein. This makes these cells more susceptible to lethal damage.

To create this modified drug, scientists started by using a type of chemotherapy abbreviated as TMZ. TMZ is a drug that serves the same

function as its new modification. The issue with this original, however, was that tumors would quickly become resistant using a pathway called the mismatch repair pathway, which prompted scientists to а



solution. testing various After compounds, scientists then determined the most potent of this group, which was then named KL-50. This compound not only killed the protein deficient cancerous cells but did so regardless of the functionality of the pathway as a defense mechanism.

adapting and becoming resistant. Whereas unmodified TMZ loses its effectiveness due to this pathway healing the cell, this stronger compound is able to inflict lethal damage regardless.

Preliminary studies conducted on mice injected with human glioblastoma cells have shown that the KL-50 compound both suppressed tumor growth and, with the exception of the highest dose tested, produced no toxicity in healthy human cells.

While more tests need to be conducted on animals before the consideration of using the treatment in humans, so far KL-50 has delivered promising results. The researchers are confident in their studies, so much so that they have started a company surrounding the clinical testing of similar treatments for other forms of cancer.

What's inside NFL equipment?

It is no secret that other professional sports leagues have better and more advanced technology than the National Football League. For example, in professional tennis, balls are immediately ruled in or out when it comes to a close call on the court. FIFA uses chargeable balls that connect to several cameras on

the field that can make offside calls in seconds. However, the NFL isn't very far behind regarding technology. The NFL

been putting has Radio Frequency Identification (RFID) chips into each player's shoulder pads since 2015. The RFID chips weigh just 3.3 grams,



less than one percent of the weight of a football. They are also very small sized. These chips wirelessly turn on before a game and automatically shut off after the game ends. Each RFID chip is made to last an entire season. These chips give us statistics, including how fast a player ran for a touchdown. Also, when the offensive or defensive linemen take their position at the line of scrimmage, the RFID chip ensures that

> data transmission is possible in this position.

Shortly after placing these chips in the shoulder pads, the NFL put the same RFID chip in each football. It started with a test in the 2016 Pro Bowl, and from 2017

onward, every football has been planted with an RFID chip. The chips in the footballs help calculate a quarterback's throwing velocity, initial airspeed, average airspeed and spin rate. The RFID chip is mostly used for automatic timekeeping and for monitoring the exact position of a football player throughout the entire event.

However, the RFID chip is only accurate to six inches so ball measurement decisions are left up to the chain crew who manages signal poles on one of the sidelines.

These chips show how far the league has come regarding technology and equipment. With the NFL getting more advanced as the years go by, fans are left with more anticipation on what's next for the league.
