Introduction

The findings of a recent study showed that there is a significant benefit to students who participate in out-of-school-time (OST) programs. In fact, the Return on Investment of Summer school Programs in Pennsylvania study determined that for every dollar invested in summer school programming for students there was a return of \$6.69 in potential benefits to students, including reduced rates for dropouts, teen pregnancy, substance abuse, crime and delinquency (Link PSAYDN.org).

In accordance with the American Rescue Plan (ARP) Act and Pennsylvania Act 24 of 2021 (Act 24), the Pennsylvania Department of Education (PDE) will award approximately \$50,000,000 or one percent (1%) of Pennsylvania's ARP Elementary and Secondary School Education Relief (ESSER) State Reserve funds to support school districts, charter schools and cyber charter schools (collectively, LEAs) in the development and implementation of comprehensive after-school programs to address learning loss in response to the academic, social, emotional and mental health needs of students and subgroups of students impacted by COVID-19 public health emergency that supplement school programs and activities.

Act 24 requires that, when available, existing personnel shall be utilized by school districts, charter schools and cyber charter schools to staff programs and activities established with these grant funds.

Within 90 days of receipt of these allocations, school districts, charter schools and cyber charter schools must submit a three- part plan to PDE, that outlines the proposed use of the grant money, itemized by program and activity. This plan is part of a consolidated application that includes after-school programming, summer programming, and a comprehensive plan to address learning loss. The plan shall include:

- 1) A description of each program and activity
- 2) A narrative outlining the expected benefit of each program and activity
- 3) A budget for each program and activity detailing personnel and operating costs

PDE has developed the Accelerated Learning Toolkit, a significant cadre of resources and trainings, to support LEAs in the development of their plans. The Accelerated Learning Toolkit can be found Link to Accelerated Learning Toolkit.

Indicators of Impact

1. Describe how the LEA identified students for inclusion in a summer school program. Include a brief description of the indicators used in the decision-making process.

All elementary students participate in academic screenings a minimum of three times per year. Students who score below proficiency on 2/3 of the benchmark exams are identified to receive targeted academic support through either out Title I and/or Special Education programs. The

benchmark testing at the end of the year shall determine student academic need for continuous programming. Students scoring below proficiency, or those exhibiting the need for social/emotional support services shall be invited to attend camp programs during the summer. Students in May/June shall be invited to select weeks to attend summer camp. Additionally, secondary students who are not achieving success in their academics and who are in need of academic support or credit recovery may attend summer school. The secondary summer school program offers a virtual curriculum delivery platform, however students shall be required to attend in person and will receive support from district teachers for completion of the coursework. Previous data from the summer of 2020 indicated that pass rates for these courses dramatically declined when students did not attend class in person.

Curriculum from Florida Virtual courses will be purchased to assist in remediation and credit recovery for secondary students. The mode of delivery is on-line however the district will require in person participation in the secondary summer school program so students can be progress monitored by classroom teachers and special educators. Small group and 1:1 assistance shall be provide. Additionally, student progress reports shall be shared with parents/guardians on a biweekly basis. The elementary summer school program offers student a fun enrichment program. Students will have the opportunity to participate in arts, crafts, technology, science, reading and mathematics activities and games. This program is geared toward building student collaboration and socialization under the guidance of certified teachers and other professional faculty.
